## SUMMARY ANNUAL REPORT FOR SOUTHERN OREGON HEAD START RETIREMENT PLAN

This is a summary of the annual report for the SOUTHERN OREGON HEAD START RETIREMENT PLAN (Employer Identification Number 93-0564896, Plan Number 001) for the plan year 11/01/2020 through 10/31/2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

## **Basic Financial Statement**

Benefits under the plan are provided by insurance contracts. Plan expenses were \$1,268,172. These expenses included \$5,531 in administrative expenses and \$1,262,641 in benefits paid to participants and beneficiaries, and \$0 in other expenses. A total of 597 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$10,508,890 as of the end of the plan year, compared to \$8,503,452 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of \$2,005,438. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$3,273,610, including employer contributions of \$608,956, employee contributions of \$438,777, and earnings from investments of \$2,052,214.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
