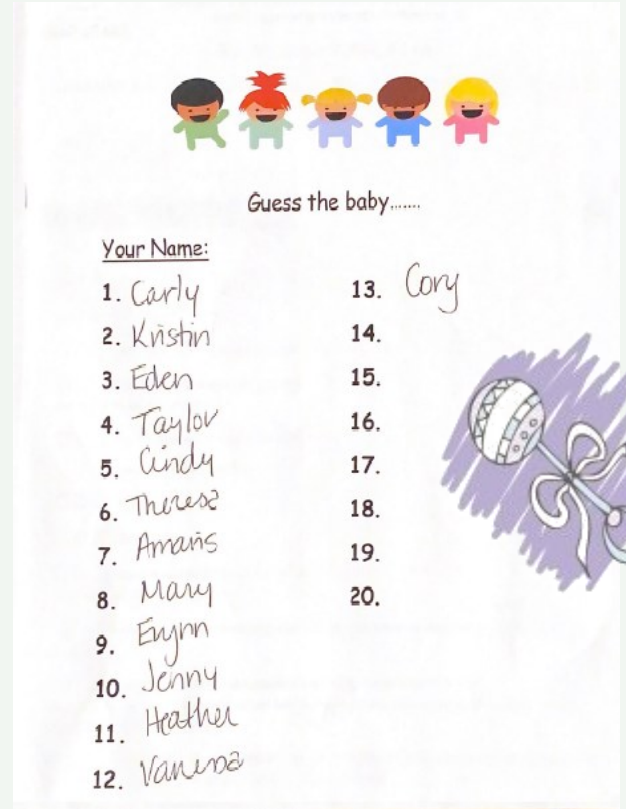
We were so thrilled when a Site Manager shared an act of kindness and dedication by one of their staff for a family in need, and had to pass along our appreciation and recognition!
