


Step-by-Step to complete the Vaccine Education Certificate (VECC) videos for Non-Medical Exemption for vaccinations

This guide should help you understand the process and help you answer questions parents may have about getting their VECC.

Nonmedical Vaccine Exemptions

There are two ways to claim a nonmedical vaccine exemption in Oregon.

Option 1

Watch an online vaccine education module and submit a certificate of completion.

IMPORTANT! Read before you start the module:
To protect your privacy, we do not store any information. For this reason, you will need to start over if you close the module before you are finished.

- Allow 15 to 60 minutes to finish this module. The amount of time depends on the number of vaccines for which you are getting an exemption.
- If you need to take a break, leave the module window open.
- When you reach the end, make sure you print, save, or take a screenshot or picture of your Vaccine Education Certificate before leaving that screen. You

Parents / Guardians

- Watch the Vaccine Education Module for children in child care, preschool, or K-12 and print out the Vaccine Education Certificate at the end of the module.
- Fill out the nonmedical exemption section of the [Certificate of Immunization Status form \(pdf\)](#).
- Turn in both forms to your child's school or child care.

Option 2

Talk to a health care provider and have them sign a Vaccine Education Certificate.

Parents / Guardians

- After talking with your health care provider, s/he can give you a signed Vaccine Education Certificate.
- Fill out the nonmedical exemption section of the [Certificate of Immunization Status form \(pdf\)](#).
- Turn in both forms to your child's school or child care.

College Students

- After talking with your health care provider, s/he can give you a signed Vaccine Education Certificate.

Once they click on the language, a new window or tab will open, and they will play the introduction.

It's best to watch all at once for all imms they want to exempt from. They will have to watch the whole intro each time they come back to watch a video for an imm- and that alone is about 15 minutes. Plan 10-15 minutes for each additional immunization they will watch the video for.

If you leave the videos your progress will be lost and you will have to start them all over.



This is where they choose where to start. If they only want to exempt from one immunization, they only need to click on that immunization's name. If they want to exempt from multiple, they select one to start and will come back to this menu when each video ends.



Completed videos will be green, unwatched videos will remain blue.

In this example, the parent only wants to exempt their child from Polio and Varicella. They will be required to be up to date by exemption day on the remainder of the required immunizations.



The parent will be prompted to type their name at the end, the child's name will be handwritten or added later.

The immunizations the child is exempt from are listed here. If there is one missing, they will need to go back and complete the video for that immunization.

They can mark their reason for exempting if they want. It is an optional question.

This is the screen to enter the parent/guardian's name and on the right shows what immunizations will appear on the certificate.



To download your certificate, type your first and last name then click "Download Certificate". Be sure to enter your name, not your child's name. Your certificate will download in .pdf format. Please note that you will not be able to edit your name after you click "Download Certificate". To avoid errors on your certificate, please do not use autocorrect or autocomplete when typing your name.







There are options for getting the child's name on the certificate:

1. Parent prints certificate and handwrites child's name & birthday, then takes a picture and sends to center (or bring to center), center will then scan and email to Chalesa Duewall
2. The parent has a program that allows them to type their child's name and birthday before sending into center staff, center will then send to Chalesa Duewall
3. If staff have ability to type the child's name before sending to Chalesa Duewall
4. Staff print out and handwrite child's name and birthday, then scan and email to Chalesa Duewall
5. Staff send the VECC to Chalesa Duewall with child name and birthday, she will add to certificate.





This screen is a little different, it does not show them what immunizations will appear on the certificate. They are only prompted to enter the parent/guardian's name.



The certificate will show up on their phone, they can either screenshot this and send it to you, or if they have the ability, they can email it directly to the center or themselves.

On an iPhone, if they tap this symbol, it will show the options they have. This is where they can send it in an email from this screen.


