#### **EXECUTIVE DIRECTOR'S REPORT**

**Kathrine Clayton- Executive Director** 

- -PIS Transitions from Head start to kindergarten. The Federal Review was completed June  $6^{th}$  and final report should be out in 3 to 4 months.
- Vehicle leases will be a new vehicle(s) every 3 years.

#### New Vehicle Leases

The agency is planning to lease rather than purchase two vehicles to replace two damaged vehicles. A request was made to approve the 2021-2022 HS and EHS re-budgets for the vehicle leases.

- The 2021-2022 budget will fund the down payment of \$8,337.27, fees, and August-October lease payments.
- The 2022-2023 and 2023-2024 budgets (from *Other Furniture Equipment* < \$5K and *Center Furniture & Equipment* < \$5K) will fund 12 months of lease payments at \$9,349.08 per month.
- The 2024-2025 budget will fund the remaining 9 months of lease payments at \$7,011.81 per month.

Catherine Ziel, EHS Grants Pass, moves to approve the re-budget for new vehicle leases. Sarah Nash, South Medford, seconds the motion to approve the re-budget for new vehicle leases. Any opposed? No. Any abstentions? No. Motion was carried.

- Changes to Collective Bargaining Agreement A 2-week notice is required now instead of a 30 notice for employees quitting.

#### **OPK Grant Amendments**

The agency received notice from the state regarding the inflationary adjustments for 2021-2022 and the award for 2022-2023.

- 2021-2022: An increase of \$308,194.71 for HS and \$10,008.00 for EHS.
- 2022-2023: An award of \$8,127,023.56 for HS and \$453,600.00 for EHS with a startup award of \$25,000.
