- 7. Child kicked and caught employee's hand and broke the skin.
- 8. Employee was head butted in the chin by student causing jaw pain with a chipped tooth.
- 9. Employee smashed finger in kitchen drawer
- 10. Employee scratched by student

#### **Action Items:**

1. Laurie will look into different covers for the sandbox.

#### **Center Safety Concerns:**

- 1. EP; Position of the playhouse is a concern however there isn't anything that can be done. Concerns of congestion at the door during pick up and drop off in the afternoon. Overlapping times and parents.
- 2. FTL; Concern of excessive force needed to open the front door. Laurie suggested to submit another work order to be fixed.
- 3. ABC; Cats are still using the sandbox as a litter box.

#### Investigating Incidents: digging deep to the root cause

- 1. An accident is an unplanned, unwanted, but controllable event which disrupts the work process and causes injury to people.
- 2. An incident may disrupt the work process but does NOT result in injury or damage. A "wake up call".
- 3. Direct Cause- unplanned release of energy or hazardous materials.

- a. In direct cause- unsafe acts and/or unsafe conditions
- b. Root Cause- Policies and decisions, personal factors, environmental factors.
- 4. The "five whys" is one of the simplest of the root cause analysis methods. It is a question-asking method used to explore the cause/effect relationships underlying a particular problem. Ultimately the goal of applying the 5 whys method is to determine a root cause of a defect or problem.
